


# Moving forward with your support

## Dear Friends,

Much has changed in this momentous year of Coronavirus, but our determination to support and deliver the collective work of Quakers across Britain is unchanged.



Over the last six months:

- Our meeting support team, with its local development workers, have supported local meetings through the pandemic.
- Friends from across the UK joined our virtual workshops, learning how to play a part in campaigning for justice, sustainability and peacebuilding.
- The Children & Young People's team provided online spaces for young participants from all across Britain.

Our vision for thriving Quaker communities and a sustainable and peaceful world is unchanged.

But it's going to be a challenge. The financial impact of the pandemic on our income was mitigated in 2020 by our strong reserves. Our unrestricted reserves will be £2m lower by the end of 2020. Our income for the year ahead is uncertain.

To move forward together, we need the ongoing financial support of meetings, Friends and attenders.

By supporting us now, you can give us the gift of certainty – the certainty to deliver the collective work of Quakers through the year ahead.

Please do give what you can – equal generosity means that Friends give what they can afford with some giving more and some giving less.

Together, we can ensure that Quaker communities thrive and that Quaker voices are heard for years to come.


